

San Antonio Symphony Audi Raffle Rules:

1. TO ENTER. From April 12, 2019 through June 9, 2019 at 7:30 pm (CST), ("Entry Period"), entrants may enter the San Antonio Symphony Car Raffle ("Raffle") by purchasing a raffle ticket from an authorized employee or agent of the San Antonio Symphony for \$125 each, or in blocks of ten (10) tickets for \$1,000 per block, payable to the San Antonio Symphony. Tickets may also be purchased over the internet at: www.sasymphony.org

NOTE: DEADLINE TO PURCHASE TICKETS ONLINE IS Friday, June 7, 2019 at 11:59 pm CST

OFFICIAL DRAWING. The official drawing will take place on June 9, 2019 at approximately 8:00 pm at the Symphony Gala at the St. Anthony Hotel, 300 E. Travis St., San Antonio, TX 78205. Need not be present to win.

2. SPONSOR. The Raffle is sponsored by the San Antonio Symphony, a Texas non-profit corporation ("Sponsor"). All decisions of the Sponsor are final.

3. CONDITIONS. An eligible entrant may enter only via the ticket purchasing methods as described above. Incomplete entries are void. By entering, entrants acknowledge compliance with these official rules including all eligibility requirements. All entries become the property of the Sponsor and will not be returned. Neither Sponsor nor advertising and promotion agencies are responsible for incorrect or inaccurate transcription of entry information, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. No copies, facsimiles, or reproductions of entries will be accepted.

4. DETERMINATION OF WINNER. A random drawing will be conducted on June 9, 2019 from among all eligible entries received. Odds of winning depend upon the number of eligible entries received. The maximum number of tickets to be sold is 999; thus the odds of winning are 999 – 1, OR BETTER. The winner will be notified by telephone, mail, and/or email. The winner will be required to complete an affidavit of eligibility and release, which must be completed and returned within five (5) business days of issuance of notification or an alternate winner will be selected. Any attempt to deliberately damage the content or operation of this Raffle is unlawful and subject to legal action by the Sponsor or its agents. TICKETS (PRIZE) ARE NON-TRANSFERABLE AND CANNOT BE SOLD.

5. PRIZE. The winner will receive a 2019 Audi A3 Cabriolet Convertible as their prize.
